Bill Pay Changes Effective March 1, 2010

Bill Pay service will be available for FREE to members who have direct deposit and eStatements, and use Bill Pay at least three times during the month.

Bill-pay monthly fee is \$5, effective March 1, 2010 for accounts not meeting the above criteria.

MasterCard® Changes Effective April 1, 2010

Platinum card fixed annual percentage rates will increase from 6.9% to 8.9%.

Opt-out provisions will apply.

- 1. Never use your children's names, birthdays, pets' names, your street address or the last four digits of your phone number.
 - 2. Combine letters, numbers and other characters such as \$ and !.
 - 3. Change your password often.
 - 4. Do not keep a written copy of your passwords in your wallet or calendar.


- Open a checking account if you don't already have one.
